Please forgive the delay in responding. The holiday brought several big events and then an opportunity to get out of here for a few days.

We have two facilities – our main stage which is a proscenium stage, 38 fly lines, sprung floor, orchestra pit with audience seating of 1,500. The second space is our Studio Theatre or black box theatre. Totally flexible seating and staging. There is no basic light plot in this space and a maximum audience size of 200, depending on the set-up.

Attached is a rental information sheet with prices. We reserve the right to approve all technicians who would be working in the facility if you do not use our crew, which is billed at \$15 per person per hour with a four hour minimum for each call. You asked about insurance requirements. We ask that the production company provide us with a one million dollar policy. There is additional information in the contract that I will send you once we have settled on space and time.

I need to know which space you are requesting before I can answer about dates. And, do you have specific dates in mind? How soon would you be ready to put the show up? Just so you know, both spaces are booked about 300 days a year with priority going to TCC productions, but I am hopeful we can find a date that works for you.

My stage manager for Little Women, Molly Dougherty, voiced a concern last night. I always ask her if she is ok or wants me to walk with her to her car after rehearsal and she has always said, "No" in the past. Last night, she expressed to me that she was very concerned for her, and others, safety in light of the Collegian articles and press that the Trey Barnett case has been receiving. She was concerned that someone looking to retaliate against the Theatre dept would come in and simply find the first person they could and do them harm.

I advised her to always call security, even in daylight hours, for an escort. I stayed around an extra 30 minutes and will make sure in the future that all students are out or have called for an escort before I leave. I, myself, am concerned for my own safety and have either my husband come up every night and walk me to and from the building or I will call security.

Considering that unknown persons leafleted your office door, considering that Chris Mangum has control and impulse issues and an unlawful entering and detaining charge (he broke in and held someone against their will) against him and considering that the victims are 4 women who will be perceived as being weaker, could we please get a security guard here in the building?
