

We are in receipt of Mr. Jim's email message today which included as an attachment a copy of an "Order Setting Hearing," dated January 31, 2018. Our office was not contacted by either of you to coordinate schedules. The "Order" presented to our office today includes no lines for approval as to form by Defendant's counsel. Also, it is not signed by either of you, (or, obviously, anyone from this office.) Thus, it appears the Order may be defective in several regards which shall be brought to the Court's attention.

Further, Mr. McHugh represented by telephone to this office that he was seeking to have all motions in the above-referenced case, as well as motions in your client's husband's case against the University of Tulsa, heard at the same hearing. Those motions were filed by Tulsa Community College employees in the University of Tulsa case to quash subpoenas directed to them. However, we have received no orders in that case regarding when those motions will be heard. Is it still your intention to hold both cases' motions at the same time? If so, did you notify the Judge of that?

While professional courtesy may or may not matter to clients, attorneys should be able to treat one another with more professionalism and consideration. In the future, we would appreciate it if you would take the time to coordinate scheduling hearings so as to avoid having to reset and reschedule things so frequently. Please let us know about the items above at your earliest convenience.

He said it did appear that it was done with the intention of trying to scare him and censor him. The Judge urged both parties to reach a resolution. To date, The University of Tulsa demands that Trey send an offer to settle. It works both ways. If the University of Tulsa were truly interested in trying to reach a settlement with Trey, they would make an offer, however they just keep demanding that Trey make a demand which is very unusual. Chris Barnett has offered to settle his claim with the University of Tulsa for \$5,000,000.00. (FIVE MILLION DOLLARS). The pain and suffering that the intentional, wreck less acts have caused towards both Chris and Trey Barnett are astounding. They need to pay a penalty for their actions. 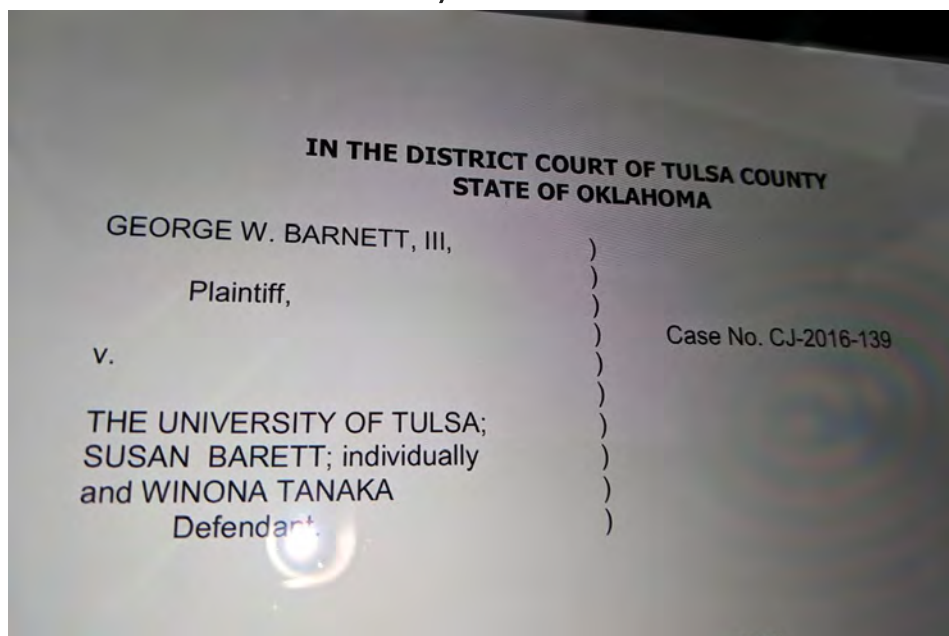

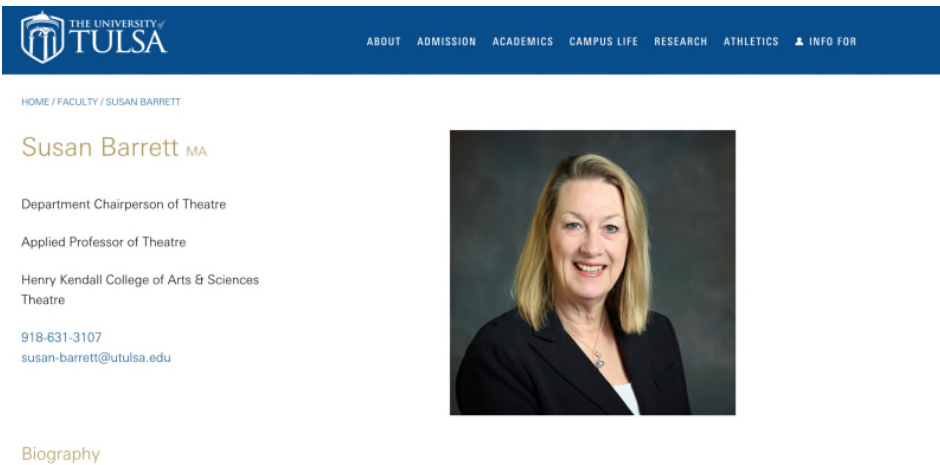

Dear Mr. Mangum,

A complaint has been filed against you by a TU faculty member alleging harassment and intimidation. 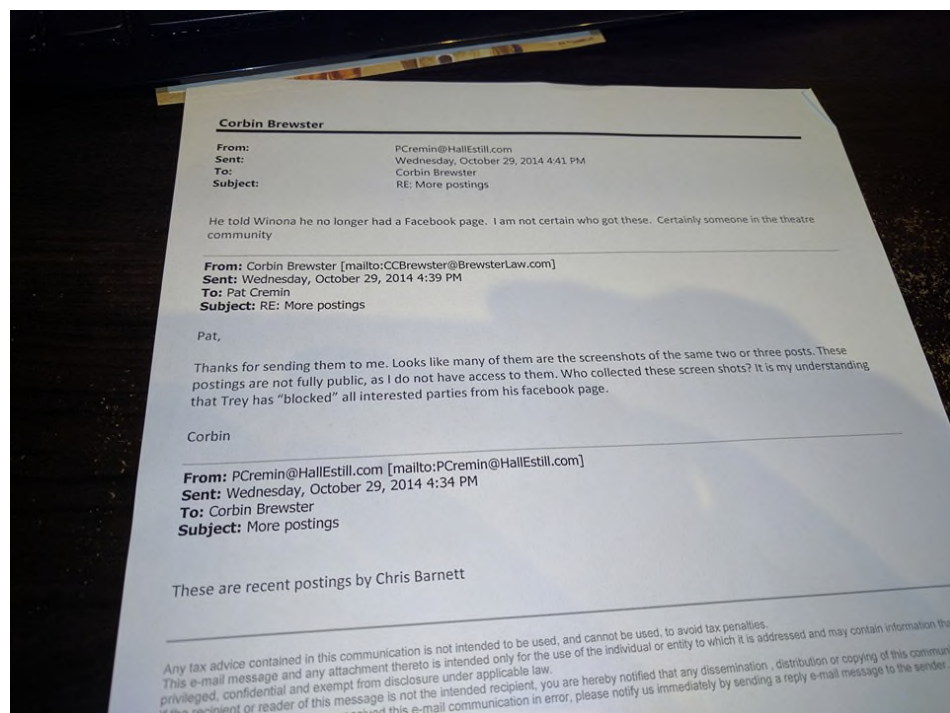

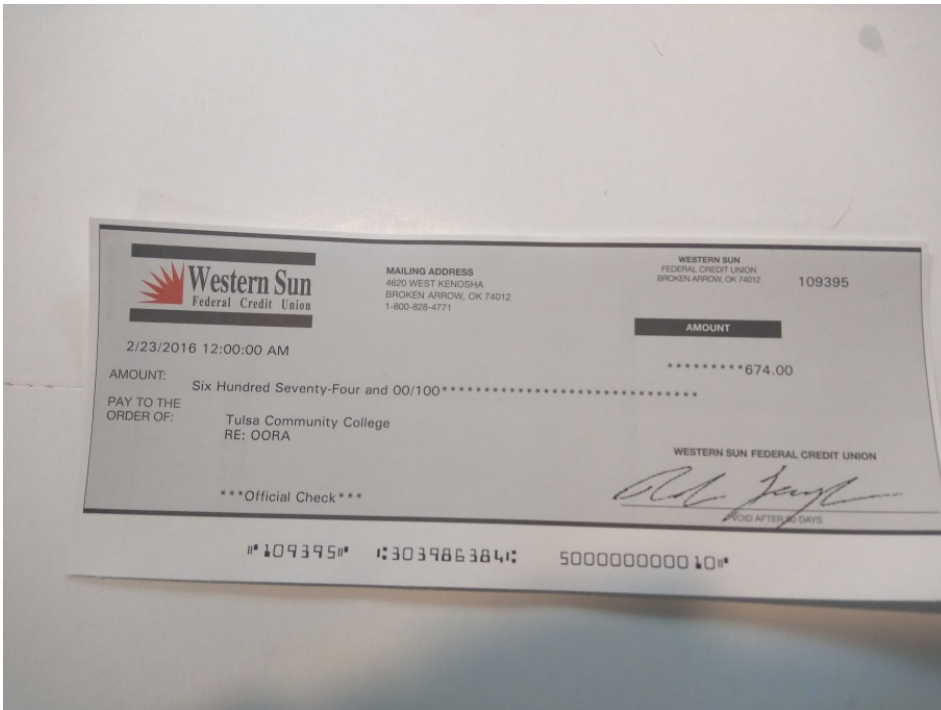
