### SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT

The above named defendant was arrested for the following reasons;

### PROBABLE CAUSE

On March 18, 2009 at approximately 9:35 p.m., Damian Louissaint and Lamar Lloyd entered Stuart Sunoco in Martin County Mr. Louissaint pulled out a small black gun, pointed at the clerk, Kazi Punir and demanded the money. Mr. Punir handed them the cash drawer from the register and they took the money. They also took several packages of Black and Mild Cigars, Newport Cigarettes, and several packages of chewing gum. Mr. Punir immediately called 911. D/s Craig Smith responded to the scene. I arrived and spoke with the owner who advised that there was approximately \$400. in cash taken and \$300. in cigars, cigarettes, and gum. The 2 males were described as tall ( 5'11" to over 6') and thin. They were in black clothing. Prior to the robbery a bolo had been issued for a suspicious vehicle with at least 2 black males seen possibly casing a restaurant. D/S Beath had been looking for the vehicle when she had responded to assist Stuart Police Department who were working a

robbery at the Pizza Hut(2024 SE Federal Highway), Stuart, FL. After the robbery had occurred at the Sunoco, the deputies were asked to cover the intersections. D/S Beath had seen the vehicle (from bolo) pass through the intersection. She followed the vehicle and several units did a felony stop on the vehicle. There were 2 children in the vehicle J.W. (age 5) and D.W. (age 2): The children were turned over to their maternal grandmother and the abuse hotline was called. Mr. Louissaint and Mr. Lloyd were passengers in the vehicle that was stopped. They were both identified by Kazi M. Punir ( Clerk at the Sunoco) who was taken to the traffic stop by D/S Youngblood (#112), Louissaint and Lloyd were also identified by the clerk fromt the Pizza Hut where the earlier robbery had occurred. The driver, Louissaint and Lloyd were arrested and taken to Martin County Criminal Investigations Division. The contraband, money, gun that were found int the vehicle were consistant with the items in the robbery. The vehicle was taken to MCSO Sheriff's and placed in evidence garage. Det. Kittredge (SPD) and I did a video taped interview on Mr. LLoyd. Lloydt was read his Miranda Rights and agreed to talk after signing a Waiver of Rights form. LLoyd admitted to robbing both the Pizza Hut and the Sunoco. He admitted to beingwith the person who pointed a gun on the clerks and demanded the money. Mr. Lloyd is arrested for committing an armed robbery at the Sunoco Station at 4504 S. Federal Hwy., Stuart, FLorida in Martin County.

 The above named defendant was arrested for the following reasons:  
On 03/18/2009, the def. + Co. Def. entered the Pizza Hut located at 2040 SE. Fed. Hwy. Stuart, FL. The def.'s confronted the employee/witness at the front door. The def.'s acted as if they were going to order food and the employee asked them what they wanted. At this point, the co def. raised his hand and exposed a small black revolver. The employee (Daniel Guss) stated that the def. aimed the revolver at him and told him "I'm ordering the money". The employee was in fear for his life and handed over approx \$150.00 from the cash register. The employee said that both initially did not have their faces

Covered, but once the revolver was exposed the def's tried to cover their faces. The Co-def used his hat and the def. used a "Hockey" mask. The def's then asked the employee to open the safe and the employee showed them that it was a time lock safe. The def's left after this. There was no injury during the robbery.

Shortly after the robbery, the def's committed a second Armed robbery at the Sunoco Gas Station located at 4504 SE. Fwd. Hwy. Stuart, FL. This incident occurred at approx. 9:35pm. The M.C.S.O. was able locate the suspects and performed a traffic stop on their vehicle. This stop took place on SE. Palm Beach Rd. in Stuart, FL. The vehicle was occupied by the def's and the driver, Cortina R. Wobbleton. All 3 suspects were hand-cuffed during the felony stop. It was then discovered that there was 2 young children inside the vehicle belonging to Wobbleton (ages 2 + 5 year), that were inside the vehicle during both armed robberies.

The witness (Guss) was driven to the arrest scene and identified both def's (Loussaint + Lloyd). All 3 subjects were placed into patrol vehicles. Search incident to arrest of Wobbleton's vehicle revealed a black in color Colt .32 cal revolver, a white "Hockey" mask, several packages of cigars + Cigarettes.

All 3 def's were transported to the Martin County Sheriff's office where they were read the Miranda rights warning. The def's understood them and agreed to speak. Post Miranda, the def admitted to his involvement in the robberies and knowledge of the firearm being used. The confession was recorded.

The def's was charged with Armed Robbery with Firearm and will be held at
