

19 I, the undersigned, say, on information and belief, that in the
20 County of SAN JOAQUIN, State of California:

22 **COUNT 1: CONTINUOUS SEXUAL ABUSE OF CHILD PC.288.5(A)**

23 On or about September 1, 2016 - November 15, 2016, in the County of
24 San Joaquin, California, LYLE BURGESS, did commit the crime of
25 CONTINUAL SEXUAL ABUSE OF A MINOR UNDER 14 YEARS, in violation of
26 Section 288.5(a) of the Penal Code, a FELONY, who at the time and


1 place last aforesaid, while residing in the same home as, or having
2 recurring access to, a child under the age of 14 years, to-wit:
3 JANE H. DOE, DOB: 10/12/2010, for a period of time, not less than
4 three months in duration, engaged in three or more acts of lewd or
5 lascivious conduct and three and more acts of substantial sexual
6 conduct with said minor child, as defined in Penal Code Sections
7 288 and 1203.066. It is further alleged that the above offense is a
8 serious FELONY within the meaning of Penal Code Section
9 1192.7(c)(6).

13 If the above-named defendant(s) is/are presently on probation in
14 San Joaquin County, any evidence presented at a preliminary hearing
15 in the instant case will be used not only as a basis for a holding
16 order in this case but also as evidence of a violation of probation
17 and, at any formal hearing on that violation of probation, the
18 People will move the transcript of the preliminary hearing into
19 evidence as a basis for the violation.

21 Pursuant to Penal Code Section 1054.5(b), the People hereby

23 to the People all information and materials described in Penal Code
