ORDER GRANTING IN PART
MOTION FOR TEMPORARY
RESTRAINING ORDER

I. INTRODUCTION

The city and nation are at a crisis level over the death of George Floyd. One would be missing the point to conclude that the protests that are the subject of this motion are only about George Floyd. His death just happens to be the current tragic flashpoint in the generational claims of racism and police brutality in America. The global strength of the Black lives movement and the obvious commitment to change are a clear indication—not just to this Court, but globally—that these protests will not be short-

1 lived, and the protestors have made it clear that their determination will be relentless until
2 change and police reform is made.

3 What brings the parties to this Court today are peaceful protestors desiring to
4 engage in their rights guaranteed by the Constitution, the freedom of assembly without
5 fear of retaliation or disruption by Seattle police officers' use of tear gas, pepper spray,
6 flash bang devices, or foam-tip bullets.

7 The First Amendment guarantees that all citizens have the right to hold and
8 express their political beliefs through peaceful protests. Police cannot interfere with
9 orderly, nonviolent protests because they disagree with the content of the speech. At the
10 same time, this Court must balance these interests when violent offenders choose to
11 disrupt constitutionally protected activity.

12 For the reasons below, Plaintiffs' Motion for Temporary Restraining Order (Dkt.
13 # 6) is **GRANTED in part**.

14 **II. BACKGROUND**

15 On May 25, 2020, George Floyd died in the custody of four Minneapolis police
16 officers. Since then, nationwide outrage and protest has ensued. Protests in Seattle
17 began on May 29, 2020, just days after his death and continue to this day. Indeed, within
18 moments of this Order a statewide walkout and march is set to begin.

19 The tale of the protests is cloudy. The parties agree that the protests have been
20 largely peaceful. Dkt. # 6 at 13; Dkt. # 29 at 7-9. But on some occasions, the protestors
21 and the Seattle Police Department ("SPD") have exchanged bottles, rocks, and fireworks
22 for tear gas, pepper spray, and blast balls. Dkt. # 19 ¶ 4; Dkt. # 27 ¶¶ 12-25. On June 5,
23 2020, the SPD banned the use of tear gas, subject to some exceptions. Dkt. # 27 ¶ 21.
24 Days later, SPD deployed tear gas again. Dkt. # 8 ¶¶ 6, 11-12.

25 Plaintiffs sued Defendant City of Seattle ("City") in this Court, alleging that the
26 City violated their rights under the First and Fourth Amendments. Dkt. # 1. Plaintiffs
27 allege that during the George Floyd protests, the SPD deployed "less-lethal" weapons

1 including “chemical irritants, batons, kinetic impact projectiles, and weapons intended to
2 stun with light and sound.” *Id.* ¶ 15. Chemical irritants include tear gas (“CS gas”) and
3 oleoresin capsicum spray (“OC” or “pepper” spray). *Id.* ¶ 16. The use of these weapons,
4 Plaintiffs say, deprived them of their right to protest and to be free from excessive force.
5 *Id.* ¶¶ 140-47.

6 Hours after they filed their complaint, Plaintiffs moved for a temporary restraining
7 order (“TRO”), seeking to enjoin the City from “deploying chemical weapons or
8 projectiles of any kind for the purpose of crowd control at protests or
9 demonstrations . . . includ[ing] prohibitions on[] (1) any chemical irritant such as CS Gas
10 (‘tear gas’) or OC Spray (‘pepper spray’) and (2) any projectile such as flash-bang
11 grenades, ‘pepper balls,’ ‘blast balls,’ and rubber bullets.” Dkt. # 6-1 at 2; *see also* Dkt.
12 # 6. The City opposed that motion but, in the interest of compromise, proposed revisions
13 to the injunction that it is willing to stipulate to. Dkt. # 29 at 12-14.

14 The Court has reviewed the evidence supplied by the parties, but, of course, the
15 record is limited at this stage. Based on the Court’s review, the video and testimonial
16 evidence show that on some occasions the SPD has in fact used less-lethal weapons
17 disproportionately and without provocation. *See, e.g.*, Dkt. # 9 ¶ 3; Dkt. # 12 ¶¶ 3-4, 6-8;
18 Dkt. # 19 ¶¶ 3-4.

19 III. LEGAL STANDARD

20 Like a preliminary injunction, issuance of a TRO is “an extraordinary remedy
21 never awarded as of right.” *Garcia v. Google, Inc.*, 786 F.3d 733, 740 (9th Cir. 2015).
22 Under Federal Rule of Civil Procedure 65(b), a party seeking a TRO must make a clear
23 showing (1) of a likelihood of success on the merits, (2) of a likelihood of suffering
24 irreparable harm in the absence of preliminary relief, (3) that the balance of hardship tips
25 in her favor, and (4) that a temporary restraining order in is in the public interest. *Winter*
26 *v. Natural Resources Defense Council, Inc.*, 555 U.S. 7, 20 (2008) (articulating standard
27 for preliminary injunction); *Stuhlbarg Int’l Sales Co. v. John D. Brush & Co.*, 240 F.3d

1 832, 839 n.7 (9th Cir. 2001) (noting that preliminary injunction and temporary restraining
2 order standards are “substantially identical”).

3 **IV. DISCUSSION**

4 A few words to start: First, as other courts have recently expressed,¹ people have a
5 right to demonstrate and protest government officials, police officers being no exception.
6 Their right to do so, without fear of government retaliation, is guaranteed by the First and
7 Fourth Amendments. Second, to protect person and property, police officers must make
8 split-second decisions, often while in harm’s way. Third, the Court hopes that the parties
9 see the kinship in their arguments—not all protestors seek destruction; not all officers
10 seek violence. Finally, like previous courts, this Court recognizes the difficulty in
11 drawing an enforceable line that permits police officers to use appropriate means in
12 response to violence and destruction of property but that also does not chill free speech or
13 abuse those who wish to exercise it.

14 Here, Plaintiffs request a TRO on their First and Fourth Amendment claims. Dkt.
15 # 6. They seek to enjoin the City of Seattle, including the SPD, from deploying
16 “chemical weapons or projectiles of any kind for the purpose of crowd control at protests
17 or demonstrations.” Dkt. # 6-1 at 1. The Court analyzes Plaintiffs’ request under the
18 four *Winter* factors and addresses each in turn.²

19 **A. Likelihood of Success on the Merits**

20 Plaintiffs argue that the SPD’s use of less-lethal, “crowd control” weapons violates
21 their First Amendment right to protest and their Fourth Amendment right to be free from
22 excessive force.

27 ² The City also argued that Plaintiffs lack standing to bring their claims. The Court has
28 reviewed their brief and has heard oral argument on this issue. Based on that review, it
concludes that the standing argument lacks merit.

1 **i. First Amendment Claim**

2 To establish a First Amendment retaliation claim, plaintiffs must show that
3 (1) they were engaged in a constitutionally protected activity, (2) the defendant’s actions
4 would chill a person of ordinary firmness from continuing to engage in the protected
5 activity, and (3) the protected activity was a substantial or motivating factor in the
6 defendant’s conduct. *Pinard v. Clatskanie Sch. Dist. 6J*, 467 F.3d 755, 770 (9th Cir.
7 2006). At this stage, Plaintiffs have made a clear showing of all three elements.

8 First, the right to protest—including activities such as “demonstrations, protest
9 marches, and picketing”—is clearly protected by the First Amendment. *Collins v.*
10 *Jordan*, 110 F.3d 1363, 1371 (9th Cir. 1996). Since “time immemorial,” city streets and
11 sidewalks have been deemed public fora, and as such any First Amendment restrictions
12 placed on them are “subject to a particularly high degree of scrutiny.” *Id.* “Speech that
13 stirs passions, resentment or anger is fully protected by the First Amendment.” *Id.* (citing
14 *Terminiello v. Chicago*, 337 U.S. 1, 4 (1949)). Indeed, the First Amendment “protects a
15 significant amount of verbal criticism and challenge directed at police officers.” *City of*
16 *Houston, Tex. v. Hill*, 482 U.S. 451, 461 (1987) (explaining that yelling obscenities and
17 threats at a police officer is still protected under the First Amendment). The law is clear
18 that the government may not prohibit angry or inflammatory speech in a public forum,
19 unless it is both “directed to inciting of producing imminent lawless action” and “likely to
20 incite or produce such action.” *Collins*, 110 F.3d at 1371.

21 Plaintiffs show that they were engaged in the constitutional right to protest police
22 brutality. They exercised their right on public fora. The video evidence reveals that
23 many of these protests occurred on Seattle streets, often right outside the police precinct
24 on Capitol Hill. Dkt. # 8 ¶¶ 2, 6, 11-12 (videos of June 8 protest); Dkt. # 19 ¶¶ 3-4
25 (videos of June 1 and June 2 protests). On this record, their protests have been passionate
26 but peaceful, and they must thus be protected even if they stand in opposition to the
27 police. The video and testimonial evidence reveal as much. *See, e.g.*, Dkt. # 9 ¶ 3; Dkt.

1 # 12 ¶¶ 3-4, 6-8; Dkt. # 19 ¶¶ 3-4.

2 Both parties agree that some protesters did launch objects at the police, ranging
3 from rocks, bottles, fireworks, traffic cones, traffic flares, and more. Dkt. # 9 ¶ 3;
4 Dkt. # 12 ¶ 11; Dkt. # 27 ¶¶ 12-25. Moreover, the City represents that SPD confronted
5 “significant arson events, assaults on civilians and officers, as well as wide-spread looting
6 and property destruction,” among other criminal activities. Dkt. # 29 at 7. This, no
7 doubt, poses a serious threat to officer life and safety. *Id.* at 19. But, as to these
8 protestors, the Court agrees with Plaintiffs’ reading of *Collins*: “the proper response to
9 potential and actual violence is for the government to ensure an adequate police presence,
10 and to arrest those who actually engage in such conduct, rather than to suppress
11 legitimate First Amendment conduct as a prophylactic measure.” 110 F.3d at 1372.

12 Reiterating its initial remarks, the Court acknowledges that it is difficult to balance
13 these public safety concerns and constitutional rights. But the Court holds that the
14 balance here tips in favor of Plaintiffs, and other peaceful protesters, who were engaging
15 in and may continue to engage in their constitutional right to protest.

16 Second, SPD’s actions would chill a person of ordinary firmness from continuing
17 to protest. “Ordinary firmness” is an objective standard that will not “allow a defendant
18 to escape liability for a First Amendment violation merely because an unusually
19 determined plaintiff persists in his protected activity.” *Mendocino Envtl. Ctr. v.*
20 *Mendocino Cty.*, 192 F.3d 1283, 1300 (9th Cir. 1999). The mere threat of harm, without
21 further action, can have a chilling effect. *Brodheim v. Cry*, 584 F.3d 1262, 1270 (9th Cir.
22 2009).

23 SPD’s use of less-lethal, crowd control weapons have surely chilled speech. To
24 start, exposure to tear gas and pepper spray is “excruciating.” Dkt. # 10 ¶¶ 20-31
25 (“Imagine the hottest chile pepper you ever ate, then imagine an even hotter one that you
26 would never eat, and then imagine touching that pepper and inadvertently sticking your
27 finger in your eye. That is what a small dose of pepper spray is like.”). The same is true

1 for the projectiles that SPD fires into crowds, which can cause intense pain and bruising.
2 *Id.* ¶¶ 38-47. Dkt. # 25 ¶¶ 6-7, Exs. A & B. Though “less lethal,” these devices have
3 been sufficiently lethal to deter some protestors from protesting again. *See, e.g.*, Dkt. # 9
4 ¶¶ 12-13 (“I do feel anxious though, especially about protesting because of police
5 presence at the protests.”); Dkt. # 17 ¶ 11 (“[E]very day I participate in demonstrations
6 where the Seattle Police Department are present, my anxiety undoubtedly increases. I
7 begin to worry and prepare for the same suffocating feeling I experienced because of
8 their use of extreme force and violence against peaceful protestors.”). The Court holds
9 that SPD’s use of these weapons would chill a person of “ordinary firmness” from
10 protesting.

11 Finally, Plaintiffs have shown that the protests were a substantial or motivating
12 factor in SPD’s conduct. Plaintiffs contend that SPD indiscriminately threw an excessive
13 amount of chemical agents at peaceful protests over police brutality. Dkt. # 6 at 25.
14 They argue that this reveals that a “substantial or motivating purpose” of the force was
15 Plaintiffs’ exercise of their First Amendment rights. *Id.* The Court agrees. The use of
16 indiscriminate weapons against all protesters—not just the violent ones—supports the
17 inference that SPD’s actions were substantially motivated by Plaintiffs’ protected First
18 Amendment activity. The City objects, however, arguing that the protestor’s message
19 has been constant while the SPD’s use of less-lethal weapons has decreased over time.
20 Dkt. # 29 at 16. Thus, they suggest, SPD’s actions were not motivated by Plaintiffs’
21 protest. *Id.* But it is not clear to the Court that, under the third prong of the retaliation
22 analysis, Plaintiffs must show that they were retaliated against *every* time they exercised
23 their First Amendment rights. The law clearly requires only that the SPD’s actions be
24 substantially motivated by Plaintiffs’ conduct.

25 In sum, Plaintiffs have made a clear showing of a likelihood of success on the
26 merits on their First Amendment claim.

1 **ii. Fourth Amendment Claim**

2 “A Fourth Amendment claim of excessive force is analyzed under the framework
3 outlined by the Supreme Court in *Graham v. Connor*.” *Davis v. City of Las Vegas*, 478
4 F.3d 1048, 1053-54 (9th Cir. 2007) (quoting *Smith v. City of Hemet*, 394 F.3d 689, 700
5 (9th Cir. 2005) (en banc)). Under the objective reasonableness standard, a court must
6 balance the “nature and quality of the intrusion on a person’s liberty with the
7 countervailing governmental interests at stake to determine whether the force used was
8 objectively reasonable under the circumstances.” *Id.* (quoting *Smith*, 394 F.3d at 701)
9 (internal quotation marks omitted). “Reasonableness” of a given use of force must be
10 measured from the perspective of a reasonable officer on the scene and must appreciate
11 the “split-second judgments” that officers must often make. *Graham v. Connor*, 490 U.S.
12 386, 396 (1989). The Ninth Circuit has held that it is unreasonable to use pepper spray,
13 projectile bean bags, and pepper ball projectiles against individuals “who were suspected
14 of only minor criminal activity, offered only passive resistance, and posed little to no
15 threat of harm to others.” *Nelson v. City of Davis*, 685 F.3d 867, 884-857 (9th Cir. 2012)

16 Both testimonial and video evidence establish that SPD likely violated Plaintiffs’
17 Fourth Amendment rights. Plaintiffs testify that they were peacefully protesting (or
18 reporting on the protests) when they fell victim to the weapons at issue. Dkt. # 9 ¶¶ 3-4
19 (tear gassed); Dkt. # 12 ¶ 5 (tear gassed); Dkt. # 14 ¶ 4 (pepper sprayed); Dkt. # 17 ¶¶ 3-4
20 (tear gassed). And the video evidence supports these accounts. A video of a June 1,
21 2020 protest in Capitol Hill suggests that SPD exerted excessive force without
22 provocation—the protesters were largely peaceful, SPD changed its posture by replacing
23 frontline officers on bicycles with officers donning gas masks, and then SPD deployed a
24 battery of pepper spray, flash-bang grenades, and tear gas. Dkt. # 19 ¶ 3; *see also id.* ¶ 4
25 (June 2, 2020 Capitol Hill protest). At most, this evidence shows that Plaintiffs, and
26 many protesters alike, were engaging in minor property crime and offered only passive
27 resistance at the time they were attacked.

1 The Court is satisfied that, on this record, Plaintiffs have shown a likelihood of
2 success on their Fourth Amendment claim.

3 **B. Likelihood of Suffering Irreparable Harm**

4 “It is well established that the deprivation of constitutional rights ‘unquestionably
5 constitutes irreparable injury.’” *Melendres v. Arpaio*, 695 F.3d 990, 1002 (9th Cir. 2012)
6 (quoting *Elrod v. Burns*, 427 U.S. 347, 373 (1976)). Further, “[t]he loss of First
7 Amendment freedoms, for even minimal periods of time, unquestionably constitutes
8 irreparable injury.” *Associated Press v. Otter*, 682 F.3d 821, 826 (9th Cir. 2012) (quoting
9 *Elrod*, 437 U.S. at 373).

10 Plaintiffs have established a threat of immediate, irreparable harm in the absence
11 of a TRO. They have shown a likelihood of success on their First and Fourth
12 Amendment claims, demonstrating that irreparable injury has already occurred. The use
13 of less-lethal, crowd control weapons has already stifled some speech even if
14 momentarily. And the protests are live. In fact, a statewide walkout is set to commence
15 moments after this Order is entered. Dkt. # 6 at 20. Without a TRO, Plaintiffs may face
16 the same constitutional deprivation that they experienced in days past.

17 **C. Balance of Hardships and Public Interest**

18 When the government is a party, the last two prongs of the injunction analysis
19 merge. *Drakes Bay Oyster Co. v. Jewell*, 747 F.3d 1073, 1092 (9th Cir. 2014) (citing
20 *Nken v. Holder*, 556 U.S. 418, 435 (2009)). As to the balance of hardships, “serious First
21 Amendment questions compel[.]” a finding that the “balance of hardships tips sharply in
22 [the plaintiffs’] favor.” *Cnty. House, Inc. v. City of Boise*, 490 F.3d 1041, 1059 (9th Cir.
23 2007) (second alteration in original) (internal quotation marks omitted) (quoting
24 *Sammartano v. First Judicial Dist. Court*, 303 F.3d 959, 973 (9th Cir. 2002)). And as to
25 public interest, “it is always in the public interest to prevent the violation of a party’s
26 constitutional rights.” *Melendres*, 695 F.3d at 1002 (internal quotation marks omitted).

27 The City concedes that Plaintiffs’ “constitutional rights weigh heavily on the

1 follows:

- 2 (1) The City of Seattle, including the Seattle Police Department and any other
3 officers, departments, agencies, or organizations under the Seattle Police
4 Department's control (collectively, "the City"), is hereby enjoined from
5 employing chemical irritants or projectiles of any kind against persons
6 peacefully engaging in protests or demonstrations. This injunction includes:
7 (1) any chemical irritant such as and including CS Gas ("tear gas") and OC
8 spray ("pepper spray") and (2) any projectile such as and including flash-bang
9 grenades, "pepper balls," "blast balls," rubber bullets, and foam-tip projectiles.
10 This Order does not preclude individual officers from taking necessary,
11 reasonable, proportional, and targeted action to protect against a specific
12 imminent threat of physical harm to themselves or identifiable others or to
13 respond to specific acts of violence or destruction of property. Further, tear
14 gas may be used only if (a) efforts to subdue a threat by using alternative
15 crowd measures, including pepper spray, as permitted by this paragraph, have
16 been exhausted and ineffective and (b) SPD's Chief of Police has determined
17 that use of tear gas is the only reasonable alternative available. The Chief of
18 Police may only authorize limited and targeted use of tear gas and must direct
19 it to those causing violent or potentially life-threatening activity. To the extent
20 that chemical irritants or projectiles are used in accordance with this paragraph,
21 they shall not be deployed indiscriminately into a crowd and to the extent
22 reasonably possible, they should be targeted at the specific imminent threat of
23 physical harm to themselves or identifiable others or to respond to specific acts
24 of violence or destruction of property.
- 25 (2) In the event that Plaintiffs seek relief for an alleged violation of this Order, the
26 City must respond to the motion for relief within 24 hours.
- 27 (3) Because this is a non-commercial case, the balance of hardships favors

1 Plaintiffs, and there is no realistic likelihood of harm to the City of Seattle
2 from enjoining its conduct, the Court waives the security bond requirement.
3 (4) This Order will expire fourteen days after entry unless extended by the Court
4 for good cause. Fed. R. Civ. P. 65(b)(2).
