The Affiant, Officer A Yannekis, being first sworn, says there is probable cause to believe the defendant, Isaiah Anthony Wayne Jackson, committed an offense based on the summary of facts below:

On 9/20/18, officers responded to 1508 Broadway St reference a vandalism. On officers' arrival, we were met by the victim, [REDACTED], outside the residence.

[REDACTED] stated that she was driving around the area of Sherman Ave and Stanton Ave with her friend, witness [REDACTED], when she observed the defendant, Isaiah Jackson, following her around in a red vehicle. [REDACTED] attempted to drive away from Mr. Jackson by cutting through neighborhoods, stating she was scared due to prior threats made to her. [REDACTED] stopped at the stop sign of Sherman Ave and Stanton Ave when Mr. Jackson purposefully rammed the drivers side of [REDACTED]'s car with his vehicle.

[REDACTED] then fled the scene as Mr. Jackson drove away in another direction. [REDACTED] stated that Mr. Jackson made eye contact with her prior to hitting her vehicle. [REDACTED] stated that Mr. Jackson was driving a red Oldsmobile Bravada which she believes belongs to one of his relatives.

Officers observed major damage on the driver's side door of [REDACTED]'s vehicle. Red paint transfer was visible within the damage. The driver's side mirror was hanging off the frame.

[REDACTED] (Passenger/ Witness) advised that she saw Mr. Jackson driving the vehicle prior to impact and has known him for around 6 years.

Mr. Jackson and [REDACTED] have a 2 month old daughter in common. [REDACTED] stated Mr. Jackson was becoming increasingly aggressive and violent with her, threatening her and her family. [REDACTED] stated she felt Mr. Jackson was trying to harm her and that he may have believed their daughter was in the vehicle.

Written statements were filled out by [REDACTED] and [REDACTED]. Photos were taken of the damage to [REDACTED]'s vehicle. A warrant is requested for Mr. Jackson for felonious assault and domestic violence.
