AND ACCUSATIONS:

My name is Deputy B. Wilson and I am commissioned as a peace officer by the Parker County Sheriff's Office. I hereby state upon my oath that I have reason to believe and do believe that before the making and filing of this Complaint, the defendant did, on or about the 1st day of August, 2020, in Parker County, Texas, commit the offense of Criminal Mischief Less than \$100, a Class C Misdemeanor, in that the suspect did then and there intentionally and knowingly damage or destroy tangible property, namely a green and white sign, by placing a sticker on it, without the effective consent of Parker County, the owner of the property, and did thereby cause pecuniary loss of less than \$100 to the owner, against the laws of the State of Texas.

My probable cause for said belief and accusation is as follows:


On August 1, 2020 at about 1700 hours I, Deputy B. Wilson responded to the Parker County Courthouse located at 1 Courthouse Square Weatherford, Parker County, Texas in reference to a Criminal Mischief.

I arrived on scene and met with Officers from the Weatherford Police Department. WPD Detectives Loa and Seaton observed three white males placing stickers on two different signs on the Parker County Courthouse lawn.

WPD Officer Clary located the subjects as they were walking down the road and began talking to them. One of the subjects was identified as Thomas Ryan Rousseau W/M DOB

Officer Clary advised me that Thomas admitted to placing stickers on signs. He stated that he was promoting the group listed on the stickers but was not part of it. Thomas had stickers on his person similar and identical to the ones placed on Parker County Property.

Thomas was instantered on Citation # 009352. He was transported to the Parker County Jail and booked in without incident.
